

BitcoLoan Terms of Use

Introduction

These Terms of Use (also “Terms”, “User Agreement”, “Agreement”) contains information regulating the rights, opportunities, obligations and prohibitions for both users and owners of the BitcoLoan website (bitcolan.com). The Terms apply to all website pages, as well as to the main domain child pages.

By using the BitcoLoan website, you accept this agreement and these Terms of Use and are responsible for the acts performed on the website according to the terms set out below.

If you do not agree with these Terms, you must stop using the website.

The BitcoLoan service, as well as all the website materials, are intended for people aged 21 or older. In the event that you do not fall under this requirement, you must stop using the BitcoLoan website.

BitcoLoan Intellectual Property

All the bitcolan.com content, as well as the child domain content, is the company’s intellectual property. Users cannot use this content without the express permission received from the BitcoLoan company officials.

In particular, it is strictly prohibited to use any website content for commercial purposes.

It is allowed to use this content only for non-commercial purposes and by those methods that are explicitly permitted by the Service.

BitcoLoan User’s restrictions

The BitcoLoan website user is strictly forbidden to:

1. Use resources or materials posted on the website for commercial gain.
2. Directly or indirectly interact with the website in ways that cause or are likely to cause harm to the Service or other users.
3. Directly or indirectly interact with the website in order to make it impossible or difficult for other users to use the Service.
4. Use the website to bypass or violate the law and for other illegal activities that may result in legal prosecution.
5. Try to obtain the other users’ or company’s data, as well as any other data that is confidential.

Any information and content that is not publicly posted by the company or other users is confidential. Attempts to obtain, use, steal, sell, transfer, hack or decrypt any confidential information will be considered a direct violation of this agreement. A violation of this agreement may, in certain cases, initiate legal proceedings.

User-generated content

User-Generated Content is the content of any format that is uploaded or posted by the website users. We respect any uploaded content and protect it from external influences. This content is also not part of the company intellectual property and is owned by the users who uploaded it to the website.

Content posted by users shall not contradict or violate company policies, including the Privacy Policy and Terms of Use, as well as insult, humiliate, or otherwise negatively affect other users or the company.

BitcoLoan reserves the right to remove the content posted by users without explanation or notice at any time.

No warranties

All information placed on the website pages does not guarantee any results of the service use. Any information provided on the website pages is solely of a theoretical or recommendation character and is not a public offer. This information does not guarantee the fulfillment of any expectations and results.

Limitation of liability

The BitcoLoan company and any of its representatives, employees or intermediaries in no event shall be responsible for the results of the User's interaction with the website or any of the company's products. In case of the use result or circumstances directly or indirectly related to the use of any products of the BitcoLoan website, the company, as well as its representatives, employees, owners or intermediaries do not assume any liability.

Compensation

In case you have violated any of these Terms, BitcoLoan is fully relieved of any liability for compensation, financial and labor costs, claims, actions, losses, performance of duties of any kind, including those set forth in this and other company's documents.

Communication consent

By using the BitcoLoan service, you agree to communicate with the company's representatives via SMS, email, push notifications and other communication methods for the purpose of informing about important updates, advertising and other marketing purposes.

Terms and Legislation

In the event that one or more of the paragraphs\provisions of this agreement is in conflict with the law, this agreement shall remain valid, except for those paragraphs legality of which is in question. That is, even if several paragraphs of the Terms of Use are contrary to the law, the other agreement provisions remain valid.

Changes to Terms of Use

The BitcoLoan company reserves the right to change, supplement or delete paragraphs of this agreement unilaterally and without any special notice to users at any time. Changes shall come into force from the date of publication of the new document version on the website.

Third-party involvement

The BitcoLoan company reserves the right to engage third parties, services and companies to comply with the obligations under this agreement without further notice to the User. However, the User has no right to involve third parties, companies or services to fulfill the rights and obligations set forth in this and other company's documents.

User Agreement

This agreement is the final and complete regulation on interaction between the Service and the User. All agreements, arrangements and any other Terms shall be considered null and void upon the adoption of this agreement.

Agreement and Jurisdiction

This agreement is made entirely in accordance with the law, under the jurisdiction of which the BitcoLoan owners are located. Interacting with BitcoLoan and this agreement is also subject exclusively to the law of that jurisdiction.
